## What is Teen Court?

Teen Court is a nationally acclaimed diversion program designed to divert less serious misdemeanor offenders, between the ages of 10-17, away from the more formal juvenile court. Specially trained teenagers fill the roles of mock prosecutors, defense attorneys, bailiffs and jurors. Along with an adult volunteer Judge, this group of peer jurors formulates a sentence for the defendant to complete in exchange for the dismissal of the misdemeanor charge. Utilizing the principles of Restorative Justice, Teen Court aims to provide the defendants with the opportunity to accept responsibility for their actions by completing sanctions that are designed to be constructive and rehabilitative, seeking to repair the harm done to the victims and to the community.

Teen Court attempts to interrupt developing patterns of criminal behavior by providing an opportunity to accept responsibility for unlawful behavior while increasing self-esteem and a healthy attitude towards authority.

Youth volunteers earn quality community service hours that can enhance college applications. They can also gain first-hand experience of the judicial system. ## Dress Code

Please dress appropriately. This is an official court proceeding. Acceptable clothing options include: dress pants, khaki pants, collared shirts, tie, dresses or skirts (knee-length or longer), shirts or blouses that cover appropriately.

No hats, sunglasses, headphones, earbuds, flip-flops, slides, bedroom slippers, shorts, spaghetti straps/halter tops, tank tops, sweat pants, midriff or crop tops (no exposed midriff), anything ripped or distressed or with inappropriate messages. **CELL PHONES MUST BE TURNED OFF.**

No food, drinks or chewing gum allowed.
