- All hearings and calendar calls will be held in courtroom 202.
- Dependency Advisory Hearings and Trial Commencements will be held every other Monday, starting January 8, 2024, at 1:00pm. For any of these Mondays that fall on a holiday, calendar will be the next day, Tuesday, at 1:00pm, unless otherwise announced in advance.
- Delinquency Arraignments and Pre-Trial Hearings will be held every other Tuesday and Thursday starting on January 4, 2024 at 9:00am, in Courtroom 202. The schedule of hearing weeks for the 2024 calendar year is included below.
  - \*\*Crossover (JV-D) calendar will be held the same Tuesday as Delinquency at 2:00pm.
- Shelter and Detention Hearings will be held as follows:
  11:30am on Mondays
  1:30pm on Tuesdays thru Fridays unless changed and announced in advance by the Court.
- Shelter and Detention hearings will be held via ZOOM with the option to appear in person in courtroom 202 if needed.

## Judge Cooper (Courtroom 202) Courtroom Conduct and Dress Code

- All cell phones must be on silent mode, or completely turned off (unless approved in advance)
- No talking while court is in session
- No food, drinks or chewing gum (water is permitted)
- No sunglasses on top of head
- Must sit up straight; no slouching
- No sleeping
- No reading of books, papers or tablets in courtroom, unless it pertains to your case; or if it pertains to the parents and /or children's school and/or employment.
- No shorts (Unless school uniform or program)
- No tank tops / spaghetti straps
- No flip flops or slides
- No mid-driff showing shirts / tops
- No hats, bonnets or do-rags
- No political, or profane, or drug related t-shirts
- No one piece full bodysuits or pajamas
- No sweatpants

Any violations of the above listed rules will subject you to being not allowed in courtroom until case is called; and also subject your case being called after all cases for which there is compliance with these rules are called.

All attire not listed above will be considered at the court's discretion.

Inappropriate behavior will not be tolerated.
